## Grant Funding Available For Traffic Safety Programs

The Office of Traffic Safety invites government, non-profit, and community organizations to submit proposals for funding consideration for projects or programs that reduce fatal and serious injury crashes in our communities and on Nevada's roads. A Letter of Interest (LOI) for grant funding can be submitted from January 22, 2019 through March 8, 2019 for traffic safety projects and programs that support Nevada's Highway Safety Plan. The LOI does not replace the application process and is not a guarantee of funding; however, it provides our partners an opportunity to have their ideas and proposals considered in advance of completing the full application. It is only necessary to provide a summary proposal and estimate of funds in your LOI. If your LOI is approved you will be invited to complete and submit a full Office of Traffic Safety grant application; all existing grant funding requirements apply.

Grant funds are provided by the National Highway Traffic Safety Administration for education, enforcement of traffic laws, and adoption of safe driving behaviors that address Impaired Driving, Seat Belt/Child Safety Seat Use, Motorcycle and Moped Safety, Pedestrian and Bicycling Safety, Distracted Driving, Traffic Data Collection, and Teen Safe Driving.

The Office of Traffic Safety is specifically interested in proposals that address the following:

- Impaired driving, riding or walking, including improved data collection of impaired driving statistics
- Teen safe driving and teen impaired driving issues
- Speeding and aggressive driving and riding
- Traffic safety for motorcyclists
- Pedestrian safety for pedestrians and drivers
- Judicial and court based programs
- Employer based safe driving programs
- Tribal traffic safety programs

Projects and programs that introduce innovative ideas or best practices with measurable outcomes are encouraged, as are programs that foster collaboration amongst community resources.
