Possible action may include decision to continue the rulemaking process as just described; decision to move forward to schedule a workshop; acceptance of any potential draft language input for the regulation draft.
- 5. ORAL FLUID TESTING PILOT PROGRAM (Discussion / Possible Action Item) —
 The COTI members will discuss a potential pilot roadside oral fluid testing program in Nevada so that data can be collected on its utility to make evidentiary testing decisions and determine levels and trends of drug presence in drivers stopped and investigated for possible impairment. Possible action may include a recommendation to the Director of the Department of Public Safety that such a pilot program be conducted for these purposes.
