THE PURPOSE OF THE HEARING IS TO RECEIVE COMMENTS FROM ALL INTERESTED PERSONS REGARDING THE ADOPTION, AMENDMENT AND REPEAL OF REGULATIONS PERTAINING TO CHAPTER 486 OF THE NEVADA ADMINISTRATIVE CODE (NAC) (THIS PUBLIC COMMENT HEARING HAS BEEN PREVIOUSLY NOTICED AS REQUIRED BY NRS CHAPTER 233B):

TOPIC

LCB File R129-18

Existing law requires the Director of the Department of Public Safety to: (1) establish the Program for the Education of Motorcycle Riders; (2) approve courses of instruction in motorcycle safety; and (3) adopt rules and regulations necessary to carry out the Program. (NRS 486.372, 486.375)

Amend NAC 486 in Sections 7-8 to describe the responsibilities of the Motorcycle Safety Program Administrator and the allowable expenses of the Program. Sections 9-12 is to establish rules for motorcycle safety training program providers to include; the requirements for application and contracting with the Department, responsibilities of a training provider and, establishes the approval and revocation process. Sections 13-18 establishes rules for motorcycle safety instructors to include: instructor licensing and the renewal process; requirements of an instructor to maintain a license; license suspension, revocation, and hearings; rules of conduct.

Sections 9-12 is to establish rules for motorcycle safety training program providers to include; the requirements for application and contracting with the Department, responsibilities of a training provider and, establishes the approval and revocation process.
